Grievance Resolution Process:

- **Submission of Grievance:** Students must submit their grievances in writing to the Student Grievance Committee within 10 days of the incident or decision causing the grievance.
- **Initial Review:** Upon receiving a grievance, the committee will conduct an initial review to determine its validity and whether it falls within the scope of the committee's jurisdiction.
- **Investigation:** If the grievance warrants further investigation, the committee will gather relevant information, interview involved parties, and collect evidence to facilitate a fair and thorough review.
- **Mediation/Resolution:** The committee may facilitate mediation between the parties involved to reach an amicable resolution. If mediation is unsuccessful or deemed inappropriate, the committee will propose a resolution based on its findings and recommendations.
- **Appeals:** Students dissatisfied with the committee's decision may appeal to the Principal of the institute within 10 days of receiving the decision. The decision of the governing body shall be final.

The Student Grievance Committee is committed to upholding principles of fairness, transparency, and justice in addressing student grievances. By adhering to this policy, Yashwantrao Chavan College of Science, Karad aims to foster a supportive and inclusive learning environment conducive to the holistic development of its students.

Objectives: -

2. To prevent any form of ragging or harassment within the college premises, ensuring a safe and welcoming environment for all students.
3. To raise awareness among students about the negative consequences of ragging, both for the victims and the perpetrators.

Provisional Measures undertaken to prevent ragging:-

1. The anti-ragging committee takes a review and as per grievance, the problems are solved.
2. Institute takes the undertaking of students and parents while confirming admission in college and same undertaking forms included in college admission prospectus.
3. Strict actions are taken with police and Nirbhaya squad.
4. The Ragging within and outside the campus is totally banned and anyone found guilty of ragging and/or abetting ragging is liable to be punished.

Provisional Actions to be taken against students for indulging and abetting ragging in the Institute:-

1. The Anti-Ragging Committee of the institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.
2. Every single incident of ragging a First Information Report (FIR) would be filed without exception by the institutional authorities with the local police authorities.
3. Depending on the nature and seriousness of the offense, as found, the possible penalties for those found guilty of explosion at facility level are the following or any of the following:
 - Students are not allowed to attend classes.
 - Rustication from the institute for the stipulated period.
 - Cancellation of admission.
 - Withholding/withdrawing scholarship/fellowship and other benefits.
 - Prohibited from participating in any test/examination or other evaluation process.
 - To prevent the institution from being represented at regional, national or international meetings, tournaments, youth festivals, etc.
