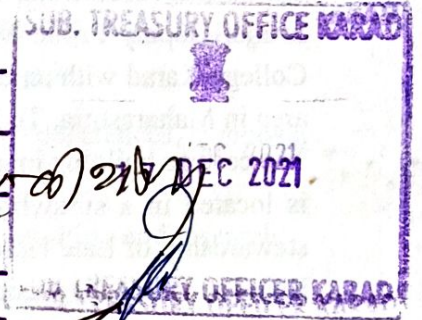

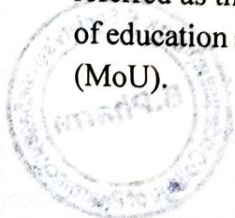
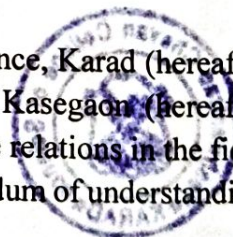

BACKGROUND OF THE ORGANIZATIONS

Shri Shivaji Education Society, Karad, founded by Late Hon. Shri Yashwantrao Chavan, former Deputy Prime Minister of India, established this college in June 1958 as Science College Karad with an objective of providing education in science to students of the Karad area in Maharashtra. To keep his memory alive, the college was renamed after him in 1986. The college building inaugurated in 1960 by the then President of India, Dr. Rajendra Prasad is located in a sprawling campus of around 40 acres and has flourished under the able stewardship of Late Hon. Shri P. D. Patil. Today Yashwantrao Chavan College of Science, Karad is one of the premier educational institution in this region. It is permanently affiliated to Shivaji University, Kolhapur. It is recognized by UGC and included under section 2F and 12(b) of UGC act. It is ISO 9001: 2015 certified and NAAC accredited B⁺⁺ Grade college, offering Undergraduate, post-graduate and PhD education Science faculty.

Kasegaon Education Society is one of the leading educational organizations in the Western Maharashtra. It was established in 1945 by Late Shri. Rajarambapu Patil, the leading statesman. Considering the need of time, the Society focused its attention on taking the education to the threshold of the rural masses. Rajarambapu College of Pharmacy, Kasegaon was established in 2005 and it has proved to be a landmark development of the Society as well as an instrument for expanse of its horizon.

Shri Shivaji Education Society's Yashwantrao Chavan College of Science, Karad (hereafter referred as the Institution) and Rajarambapu College of Pharmacy, Kasegaon (hereafter referred as the Institution), wishing to develop friendly and cooperative relations in the field of education and research have agreed to establish the present memorandum of understanding (MoU).



1) PURPOSE

The Institutions recognize mutual benefits to be derived from increased collaboration, cooperation and interaction for the purpose of promotion of awareness activities, Campaigns and conduction of various programmes including internship, conferences related to environmental sustainability, food safety, health and traditional knowledge.

2) SCOPE

This MOU sets forth the intentions of Both parties for increased collaboration, cooperation and interaction and does not create any legal binding commitments. If the Institutions later agree to undertake specific joint projects with legally binding obligations, they may develop separate written agreement for such projects, setting out contribution and deliverables.

3) OBJECTIVES

1. Yashwantrao Chavan College of Science, Karad and Rajarambapu College of Pharmacy, Kasegaon will encourage direct contact and cooperation between faculty members, staff and students of the Yashwantrao Chavan College of Science, Karad, affiliated colleges and recognized institutions of the Yashwantrao Chavan College of Science, Karad and Rajarambapu College of Pharmacy, Kasegaon.
2. To Exchange of invitations of lectures, seminars, workshops, conferences, symposia and other academic programmes;
3. To Exchange of faculty members and students for study and teaching and research;
4. To start joint research activities, publications, library and data exchange;
5. Any other specific academic activity related with study, teaching and research designed and mutually agreed between the parties.

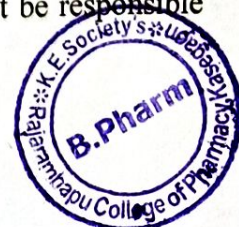
4) FUNDING:

Both parties are free to choose the pricing of programmes. The involved Both parties, on sharing basis, can develop the funds. The mechanism of funding is to be decided and executed by the Head of Institutions.

5) AGREEMENTS:

In order to inspire successful completion of this MoU, both parties agree to pledge in good faith to go forward with this MoU, subjected to the following terms and conditions.

- This MoU will take effect from the date, it is signed by head of both parties. It will remain valid for period of five years.
- Both the parties may terminate by giving written notice to the other institution three months in advance. Once terminated both the organizations will not be responsible for any losses.



- By mutual agreement, both parties may modify the list of intended activities. However, any modification to any other written part of this MoU must be made in writing and signed by both parties and their signatories.
- Nothing of this MoU permit violation of any government, state, local, UGC or university laws, imposed upon the Both parties.
- The Both parties will not compel each other that could lead to any legal hassle.
- Each organization has right to share the information they feel worth sharing. It is no binding on organization to share each and every information.
- The issue with intellectual property right can be shared only with prior permission of the concerned organization.

6) DURATION AND TERMINATION:

This MoU will take effect from the date, it is signed by head of the two institutions. It will remain valid for period of five years. Either institution may terminate the MOU by giving written notice to the other institution three months in advance. Once terminated both the institutions will not responsible for any losses.

7) AMENDMENTS / MODIFICATIONS

This MoU may be amended or modified from time to time, by written agreement signed by the representatives of both organizations.
