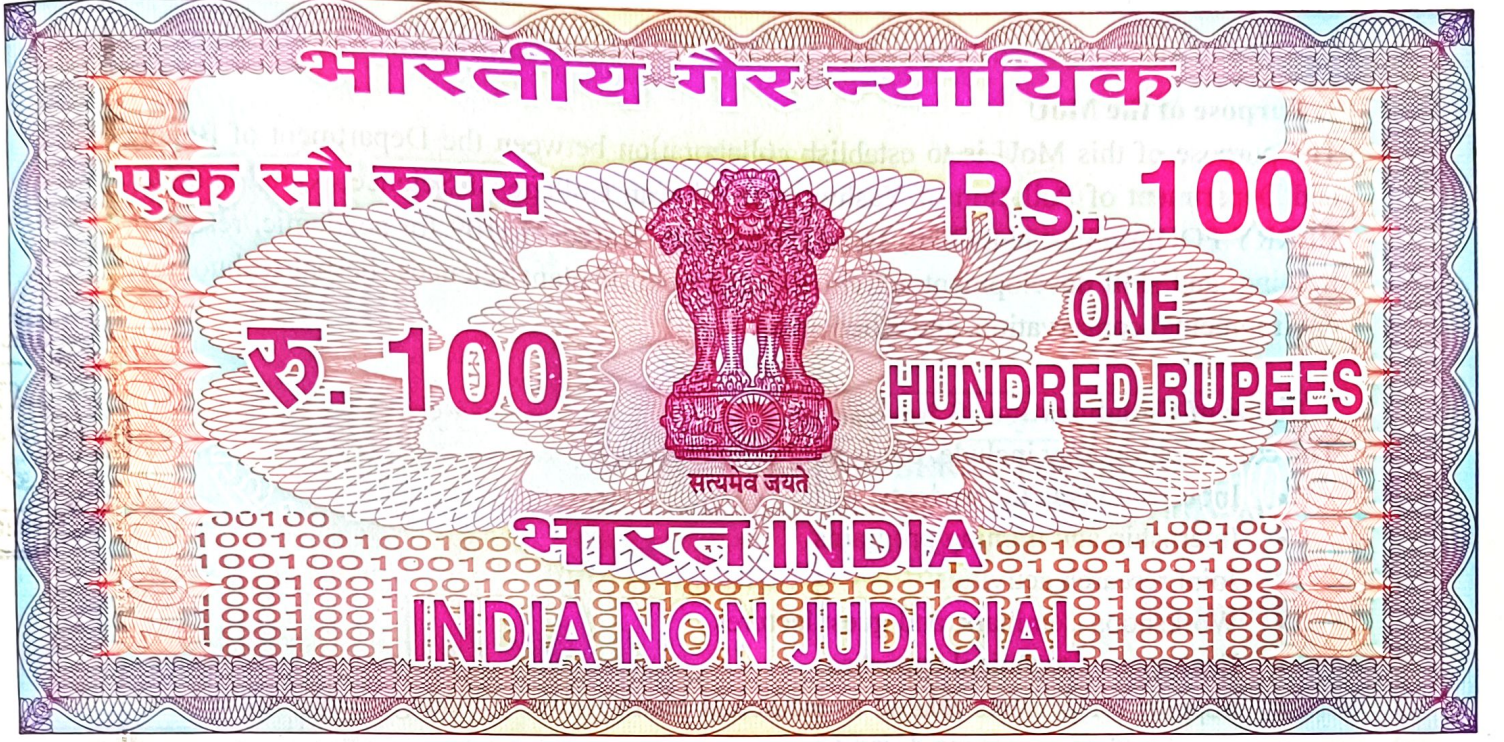

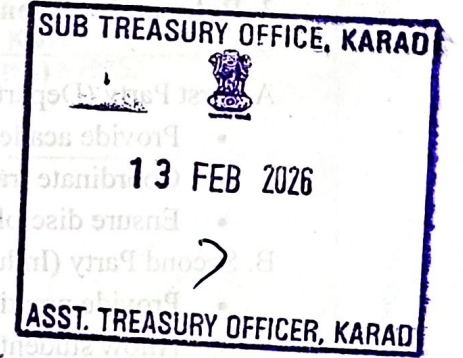

Hereinafter referred to as "Second Party"

1. Purpose of the MoU

The purpose of this MoU is to establish collaboration between the Department of Botany and Department of Pollution of Yashwantrao Chavan College of Science, Karad and M/s BERRY FOODS, Plot No. C-40, MIDC, Tasawade, Karad-415109 for academic, research, training, and skill development activities in the field of plant sciences, herbal technology, environmental conservation, and allied areas.

2. Scope of Collaboration

The collaboration may include, but is not limited to:

- Internship and training programs
- Joint research activities
- Workshops, seminars, and guest lectures
- Exchange of technical expertise
- Support for projects related to medicinal plants, nursery management, biodiversity conservation, etc.

- Ensure discipline and conduct of students

B. Second Party (Industry):

- Provide guidance on industry practices and technologies

4. Duration of MoU

This MoU shall remain valid for a period of 3 years from the date of signing and may be extended with mutual consent.

5. Financial Terms

This MoU does not involve any financial commitment unless agreed upon separately in writing by both parties.

6. Confidentiality

Both parties agree to maintain confidentiality regarding any shared information and shall not disclose it without prior consent.

7. Termination

Either party may terminate this MoU by giving 90 days written notice to the other party.

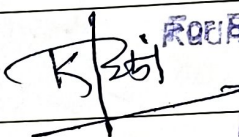
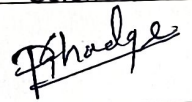
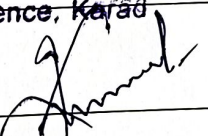
